Dear Shareholder,

I am pleased to be writing to you with details of the 2017 Annual General Meeting of PV Crystalox Solar PLC (the "Meeting" or "AGM"), which we are holding at the offices of Norton Rose Fulbright LLP, 3 More London Riverside, London SE1 2AQ on 18 May 2017 at 2.00pm.

The formal Notice of Meeting is set out on pages 4 to 6 of this document.

Ordinary business

Annual Report and Accounts [resolution 1]

The Directors of the Company (the "Directors" or the "Board") will present to the Company's Shareholders (the "Shareholders") the Annual Report and Accounts for the year ended 31 December 2016, together with the Directors' and Auditors' Reports on the Annual Report and Accounts, at the Meeting. A copy of the Annual Report and Accounts is enclosed with this document.

Approval of the Directors' Remuneration Policy and Directors' Remuneration Report [resolutions 2 and 3]

New regulations relating to the content and approval of Directors' remuneration reports came into force on 1 October 2013 for financial years ending on or after 30 September 2013 which require the Company to offer Shareholders:

- a) a binding vote on the Company's forward-looking Directors' remuneration policy at least once every three years; and
- b) a separate annual advisory vote on the implementation of the Company's remuneration policy in terms of the payments and share awards made to Directors during 2016.

Resolution 2 seeks Shareholder approval of the Directors' Remuneration Policy (the "Policy"), which is set out in full on pages 20 to 24 of the Annual Report and Accounts. If approved by Shareholders, the new Policy will be effective from the conclusion of the AGM and will remain valid for up to three years without requiring further Shareholder approval. However, should any changes be proposed to the Policy within those three years, Shareholders will be asked to approve the revised Policy by way of a binding vote. Once the Policy is approved, all payments to a current or prospective Director or a payment for loss of office to a current or former Director will need to be made in accordance with the Policy or be approved by a separate Shareholder vote.

Resolution 3 seeks Shareholder approval of the Directors' Remuneration Report (other than the part containing the Policy) for the year ended 31 December 2016. The Directors' Remuneration Report is set out in full on pages 19 to 28 of the Annual Report and Accounts. This provides details of the remuneration arrangements and payments made to the Directors during the year. This vote is advisory and will not affect the actual remuneration paid to any Director.

Reappointment of Directors [resolutions 4 to 6]

The Company's Articles of Association require all Directors to seek re-election by Shareholders at least once every three years. In addition, any Director appointed by the Board must stand for re-election at the first AGM following his or her appointment. Any non-executive Directors who have served for more than nine years are subject to annual re-election.

The Board believes that the annual re-election of Directors is in the best interests of the Company. As a result all current Directors have stood for annual re-election since the 2011 AGM. Accordingly, at the AGM all Directors will retire and, being eligible, Iain Dorrity, Michael Parker and John Sleeman will offer themselves for re-election. Each Director's biography is set out in the Annual Report and Accounts on page 17.

The Board has determined that in its judgement, John Sleeman and Michael Parker, who are being proposed for re-election as non-executive Chairman and non-executive Director respectively, meet the independence criteria prescribed in the QCA Corporate Governance Code, as each of them is independent in character and judgement and there are no relationships or circumstances which are likely to affect or could appear to affect his judgement.

During January 2017 the Board completed an annual performance evaluation of its performance and that of its Committees and individual Directors. Following that evaluation, the Chairman is satisfied that the performance of each Director proposed for re-election continues to be effective and that each of those Directors demonstrates commitment to the role. More information about these matters can be found in the Corporate Governance Statement on pages 15 and 16 of the Annual Report and Accounts.

Auditors [resolutions 7 and 8]

The Company is required at each general meeting at which accounts are presented to appoint auditors to hold office until the next such meeting. PricewaterhouseCoopers LLP have indicated their willingness to continue in office. Accordingly, resolution 7 proposes the re-appointment of PricewaterhouseCoopers LLP as auditors to the Company and resolution 8 authorises the Directors to fix their remuneration.

Special business

Authority of Directors to allot shares [resolution 9]

The authority given to the Directors to allot further shares in the capital of the Company requires the prior authorisation of the Shareholders under Section 551 of the Companies Act 2006. Upon the passing of resolution 9, the Directors will have authority (pursuant to paragraph (a) of the resolution) to allot shares with a nominal value up to a maximum of £2,778,169, which is approximately 33% of the current issued ordinary share capital (calculated exclusive of any shares being held by the Company in treasury) on 19 April 2017, being the last business day prior to the publication of the Notice of Meeting. If given, this authority will expire immediately following the Annual General Meeting in 2018 or on 30 June 2018, if earlier.

In addition, in accordance with the guidance from the Investment Association on the expectations of institutional investors in relation to the authority of Directors to allot shares, upon the passing of resolution 9, the Directors will have authority (pursuant to paragraph (b) of the resolution) to allot ordinary shares in connection with a rights issue in favour of ordinary Shareholders up to an aggregate nominal amount of £5,556,338, as reduced by the nominal amount of any shares issued under paragraph (a) of resolution 9. This amount (before any reduction) represents approximately 66% of the current issued ordinary share capital (calculated exclusive of any shares being held by the Company in treasury) as at 19 April 2017, being the last business day before the publication of this Notice of Meeting. If given, this authority will also expire immediately following the Annual General Meeting in 2018 or on 30 June 2018, if earlier.

As a result, if resolution 9 is passed, the Directors could allot shares representing up to two-thirds of the current issued share capital pursuant to a rights issue.

The Directors will continue to seek to renew these authorities at each Annual General Meeting, in accordance with current best practice. The Directors have no present intention of allotting any ordinary shares.

Disapplication of pre-emption rights [resolution 10]

If the Directors wish to exercise the authority under resolution 9 to offer shares (or sell any shares which the Company may purchase and elect to hold as treasury shares) for cash, the Companies Act 2006 requires that, unless Shareholders have given specific authority for the waiver of the statutory

pre-emption rights, the new shares be offered first to existing Shareholders in proportion to their existing shareholdings. In certain circumstances, it may be in the best interests of the Company to allot new shares (or to grant rights over shares) for cash or to sell treasury shares for cash without first offering them to existing Shareholders in proportion to their holdings.

Resolution 10 would authorise the Directors to do this by allowing the Directors to allot shares for cash or to sell treasury shares for cash:

- (i) by way of a rights issue (subject to certain exclusions) or by way of an open offer or other offer of securities (not being a rights issue) in favour of the existing Shareholders in proportion to their shareholdings (subject to certain exclusions); or
- (ii) otherwise up to an aggregate nominal value of £416,725, which is equivalent to approximately 5% of the issued share capital of the Company on 19 April 2017, being the last business day prior to the publication of the Notice of Meeting. The resolution also applies to the sale and re-issue of ordinary shares held as treasury shares by the Company. If given, the authority will expire following the conclusion of the Annual General Meeting in 2018 or on 30 June 2018, if earlier. It is intended to renew such power at successive Annual General Meetings in accordance with best practice.

The Directors have no present intention of exercising this authority (but they consider its grant to be appropriate in order to preserve maximum flexibility for the future). In accordance with the Pre-Emption Group's Statement of Principles, as updated in March 2015, the Directors do not intend to allot shares for cash on a non-pre-emptive basis pursuant to the authority in resolution 10 in excess of an amount equal to 7.5% of the total issued ordinary share capital (excluding treasury shares) of the Company other than in connection with an acquisition or specified capital investment in line with the Statement of Principles, in any rolling three-year period without prior consultation with Shareholders.

As at 19 April 2017, being the last business day prior to the publication of this Notice of Meeting, the Company held no ordinary shares in treasury.

Disapplication of pre-emption rights for an acquisition or specified capital investment (resolution 11)

The Directors are seeking further authority under resolution 11 to offer shares (or sell treasury shares) for cash otherwise than to existing Shareholders pro rata to their holdings up to an aggregate nominal value of £416,725 which is equivalent to approximately 5% of the issued ordinary share capital of the Company (excluding treasury shares) on 19 April 2017, being the latest business day prior to the publication of the Notice of Meeting. This is in addition to the 5% referred to in resolution 10. If given, the authority will expire immediately following the Annual General Meeting in 2018 or on 30 June 2018, if earlier.

This extra authority is being sought in accordance with the Pre-Emption Group's 2015 Statement of Principles. The Statement of Principles permits disapplication authorities of up to 10% of issued ordinary share capital in total to be sought provided the extra 5% is used only in connection with the financing (or refinancing) of an acquisition or specified capital investment (as defined in the Statement of Principles). The Directors confirm that they intend to use the authority sought in resolution 11 only in connection with such an acquisition or specified capital investment which is announced contemporaneously with the issue, or which has taken place in the preceding six month period and is disclosed in the announcement of the issue.

Authority for the Company to purchase its own shares (resolution 12)

The resolution is to authorise the Company to buy back up to 16,027,897 ordinary shares. The authority would expire at the conclusion of the Annual General Meeting in 2018 or on 17 November 2018, if earlier. The Board intends to seek renewal of this power at subsequent Annual General Meetings in accordance with current best practice. The resolution specifies the maximum number of ordinary shares which may be purchased (representing 10% of the Company's issued ordinary share capital as at 19 April 2017) and the maximum and minimum prices at which they may be bought, exclusive of expenses, reflecting the requirements of the Companies Act 2006 and the Listing Rules. The Board has no present intention of exercising this power and the granting of this authority should not be taken to imply that any ordinary shares will be purchased. No purchase of ordinary shares will be made unless it is expected that the effect will be to increase earnings per share and the Board considers it to be in the best interests of all Shareholders. Under the Companies Act 2006, the Company is allowed to hold its own shares in treasury following a buy back, instead of having to cancel them. This gives the Company the ability to re-issue treasury shares quickly and cost effectively (including pursuant to resolutions 10 and 11 above) and provides the Company with additional flexibility in the management of its capital base. Such shares may be resold for cash but all rights attaching to them, including voting rights and any right to receive dividends, are suspended whilst they are held in treasury. If the Board exercises the authority conferred by this resolution 12, the Company will have the option of either holding in treasury or of cancelling any of its own shares purchased pursuant to this authority and will decide at the time of purchase which option to pursue.

The total number of options to subscribe for shares outstanding at 19 April 2017, being the last business date prior to the publication of this Notice of Meeting, was 1,404,608. This represents 0.88% of the issued capital at that date. If the Company were to buy back the maximum number of ordinary shares permitted pursuant to this resolution, then the total number of options to subscribe for ordinary shares outstanding at 19 April 2017 would represent 0.97% of the reduced share capital.

Notice of general meeting (resolution 13)

Resolution 13 is a resolution to allow the Company to hold general meetings (other than Annual General Meetings) on 14 clear days' notice. Before the coming into force of the Shareholders' Rights Regulations on 3 August 2009, the Company was able to call general meetings other than an Annual General Meeting on 14 clear days' notice without obtaining Shareholder approval. Changes made to the Companies Act 2006 by the Shareholders' Rights Regulations increased the notice period required for general meetings of the Company to 21 days unless Shareholders approve a shorter notice period, which cannot, however, be less than 14 clear days. Annual General Meetings will continue to be held on at least 21 clear days' notice.

In order to preserve the Company's ability to call general meetings (other than an Annual General Meeting) on 14 clear days' notice, resolution 13 seeks such approval. The shorter notice period would not be used as a matter of routine for such meetings, but only where the flexibility is merited by the business of the meeting and is thought to be to the advantage of Shareholders as a whole. If granted, the approval will be effective until the Company's next Annual General Meeting, when it is intended that a similar resolution will be proposed.

Note that changes to the Companies Act 2006 mean that, in order to be able to call a general meeting on less than 21 clear days' notice, the Company must make a means of electronic voting available to all Shareholders for that meeting.

Action to be taken

You will find enclosed a form of proxy for use at the Meeting. Please complete, sign and return the enclosed form as soon as possible in accordance with the instructions printed thereon, whether or not you intend to be present at the Meeting. Forms of proxy should be returned so as to be received by the Company's registrars, Equiniti, Aspect House, Spencer Road, Lancing, West Sussex BN99 6DA, United Kingdom, as soon as possible and in any event no later than 48 hours before the time appointed for holding the Annual General Meeting, that is to say, no later than 2.00pm on 16 May 2017.

Recommendation

Your Directors consider that all the resolutions to be put to the Meeting are in the best interests of the Company and its Shareholders as a whole and unanimously recommend Shareholders to vote in favour of all the resolutions, as they intend to do in respect of their own beneficial holdings.

As ordinary business

1. To receive the Directors' Report, financial statements and Auditors' Report on those financial statements for the year ended 31 December 2016.
2. To approve the Directors' Remuneration Policy to take effect from the conclusion of the Annual General Meeting, as set out in the Directors' Remuneration Report contained within the Annual Report and Accounts for the year ended 31 December 2016.
3. To receive and approve the Directors' Remuneration Report (other than the part containing the Directors' Remuneration Policy) prepared by the Remuneration Committee as set out in the Annual Report and Accounts for the year ended 31 December 2016.

7. To re-appoint PricewaterhouseCoopers LLP as the Company's auditors to hold office from the conclusion of this Meeting to the conclusion of the next general meeting at which accounts are laid before the meeting.
8. To authorise the Directors to fix the remuneration of the auditors.

As special business

9. That, in substitution for all subsisting authorities to the extent unused, the Directors be and they are hereby generally and unconditionally authorised, in accordance with Section 551 of the Companies Act 2006 (the "CA 2006"), to exercise all the powers of the Company to allot shares in the Company and to grant rights to subscribe for, or to convert any security into, shares in the Company:
 - (a) up to an aggregate nominal amount of £2,778,169 (such amount to be reduced by the nominal amount of any equity securities (as defined in Section 560 of the CA 2006) allotted or granted under paragraph (b) of this resolution in excess of £2,778,169); and
 - (b) comprising equity securities (within the meaning of Section 560 of the CA 2006) up to a further aggregate nominal amount of £5,556,338 (such amount to be reduced by any shares allotted or rights granted under paragraph (a) of this resolution) in connection with an offer by way of a rights issue:
 - (i) to ordinary Shareholders in proportion (as nearly as may be practicable) to their existing holdings; and
 - (ii) to holders of other equity securities as required by the rights of those securities or as the Directors otherwise consider necessary,and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with treasury shares, fractional entitlements or securities represented by depositary receipts, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or the requirements of any regulatory body or stock exchange or any other matter.


10. That, subject to the passing of resolution 9 above and in substitution for all subsisting authorities to the extent unused, the Directors be and they are hereby empowered, pursuant to Section 570 and Section 573 of the CA 2006, to allot equity securities (within the meaning of Section 560 of the CA 2006) for cash either pursuant to the authority conferred by resolution 9 or by way of a sale of treasury shares, as if Section 561(1) of the CA 2006 did not apply to any such allotment or sale, provided that this power:
 - (a) shall be limited to the allotment of equity securities in connection with an offer of, or invitation to apply for, equity securities (but in the case of the authority granted under paragraph (b) of resolution 9, by way of rights issue only):
 - (i) to ordinary Shareholders in proportion (as nearly as may be practicable) to their existing holdings; and
 - (ii) to holders of other equity securities as required by the rights of those securities or as the Directors otherwise consider necessary,and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with any treasury shares, fractional entitlements or securities represented by depositary receipts, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or the requirements of any regulatory body or stock exchange or any other matter; and
 - (b) in the case of the authority granted under paragraph (a) of resolution 9 and/or in the case of any sale or transfer of treasury shares which is treated as an allotment of equity securities under Section 560(3) of the CA 2006, shall be limited to the allotment (otherwise than under paragraph (a) of this resolution 10) of equity securities up to an aggregate nominal amount of £416,725,

 - (a) limited to the allotment of equity securities or sale of treasury shares up to an aggregate nominal amount of £416,725, and
 - (b) used only for the purposes of financing (or refinancing, if the authority is to be used within six months after the original transaction) a transaction which the Directors determine to be an acquisition or other capital investment of a kind contemplated by the Statement of Principles on Disposing of Pre-Emption Rights most recently published by the Pre-Emption Group prior to the date of this notice,

Notes to the Notice of Annual General Meeting

1. A member is entitled to appoint one or more proxies to exercise all or any of the member's rights to attend, speak and vote at the Meeting. A proxy need not be a member of the Company but must attend the Meeting for a member's vote to be counted. If a member appoints more than one proxy to attend the Meeting, each proxy must be appointed to exercise the rights attached to a different share or shares held by the member. If a member wishes to appoint more than one proxy and so requires additional proxy forms, the member should contact Equiniti, Aspect House, Spencer Road, Lancing, West Sussex BN99 6DA, United Kingdom.
2. A form of proxy is provided with this Notice for members. Completion and return of the form of proxy will not prevent a member from attending the Meeting and voting in person. To be valid, the form of proxy and any power of attorney or other authority under which it is signed (or a notarially certified copy of such authority) must be received by post or (during normal business hours only) by hand at the Company's registrars, Equiniti, Aspect House, Spencer Road, Lancing BN99 6DA, United Kingdom, not less than 48 hours before the time of the holding of the Meeting or any adjournment thereof. Completion and return of the form of proxy will not preclude members from attending and voting at the Meeting should they wish to do so. Amended instructions must also be received by the Company's registrars by the deadline for receipt of terms of proxy.
3. Any person receiving a copy of this Notice as a person nominated by a member to enjoy information rights under Section 146 of the CA 2006 (a "Nominated Person") should note that the provisions in notes 1 and 2 above concerning the appointment of a proxy or proxies to attend the Meeting in place of a member do not apply to a Nominated Person as only members have the right to appoint a proxy.

However, a Nominated Person may have a right under an agreement between the Nominated Person and the member by whom he or she was nominated to be appointed, or to have someone else appointed, as a proxy for the Meeting. If a Nominated Person has no such proxy appointment right or does not wish to exercise it, he/she may have a right under such an agreement to give instructions to the member as to the exercise of voting rights at the Meeting. Nominated Persons should also remember that their main point of contact in terms of their investment in the Company remains the member who nominated the Nominated Person to enjoy information rights (or, perhaps the custodian or broker who administers the investment on their behalf). Nominated Persons should continue to contact that member, custodian or broker (and not the Company) regarding any changes or queries relating to the Nominated Person's personal details and interest in the Company (including any administrative matter). The only exception to this is where the Company expressly requests a response from a Nominated Person.
4. Pursuant to Regulation 41(1) of the Uncertificated Securities Regulations 2001 (as amended) and for the purposes of Section 360B of the CA 2006, the Company has specified that only those members registered on the register of members of the Company at 6.30pm (the "Specified Time") on 16 May 2017 (or, if the Meeting is adjourned to a time more than 48 hours after the Specified Time, by 6.30pm on the day two days prior to the adjourned Meeting) shall be entitled to attend and vote at the Meeting in respect of the number of shares registered in their name at that time. If the Meeting is adjourned to a time not more than 48 hours after the Specified Time, that time will also apply for the purpose of determining the entitlement of members to attend and vote (and for the purposes of determining the number of votes they may cast) at the adjourned Meeting.
